2. All displays must be fully set up Fri 22<sup>nd</sup> time TBD
3. All booths remain open and staffed during show hours. Tear down at 6pm Sun. 24th
4. Exhibitor agrees to pay all applicable sales taxes
5. Exhibitor will assume the duty and responsibility to obtain any necessary government permits or licenses.
6. All exhibitors must commence dismantling their booths immediately at the close of the event; all booths must be dismantled no later than 9pm Sept 24<sup>th</sup> 2023
7. Exhibitor shall not use combustible material at any time. must comply with the City of Sarasota Fire Department regulations.
8. Exhibitor shall not use balloons with helium.
9. Exhibitor agrees not to deface property and agrees to accept liability for any damage to the property of the City of Sarasota or other property owners.  
Any damage shall be remedied at Exhibitor's expense to the satisfaction of the property owner.
10. All wiring must conform to the City Electrical Code.
11. Assignment of space on a first come first served basis.
12. Exhibitor agrees that space assignments are subject to reasonable changes by promoter Prana 8 LLC
13. Exhibitor agrees that its displays will not disturb the aisles or adjacent exhibits.
14. No refunds will be made to any Exhibitor who fails to occupy the space.
